"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, just without the corporate limits of the City of Greenville in the vicinity of what is known as Park Place, and described as follows:

"BEGINNING at an iron pin on the North side of Second Street, 55 feet from the Northwest comer of Second Street and Second Avenue, and running thence in a line parallel with Second Avenue in a Northerly direction, 95 feet to a stake; thence in a Westerly direction and parallel with Second Street, 45 feet to a stake; thence in a Southerly direction and parallel with Second Avenue, 95 feet to an iron pin on Second Street; thence in an Easterly direction with Second Street, 45 feet to the beginning corner."

Said premises being the same conveyed to the mortgagor by J.H. Allison by deed dated June 6, 1921, recorded in Book of Deeds 68 at Page 283.
