Hicks

all that tract or lot of land in Greenville Greenville Township, Greenville County, State of South Carolina, lying and being situate on the East side of Memminger Street in the City of Greenville, having a frontage on Memminger Street of 50 feet and running back to a depth of approximately 209 feet and originally composed of one lot and a 10 foot strip off an adjoining lot and being more specifically described as follows:

A certain lot of land known as Lot No. 6 on a plat made by J. N. Southern, Surveyor and recorded in the office of the RMC Of Greenville County in Deed Book WW, page 605 with a frontage of 40 feet on Memminger Street and running back in parallel lines a distance of 200 feet, more or less, (probably 209 feet) and being the same lot conveyed to Annia A. Turner by J. D. Harris by deed dated December 17, 1901 and recorded in the RMC Office for Greenville County in Book III, page 438. Together with a 10 foot strip adjoining, which begins at a point on Memminger Street at the corner of Lot No. 6 and runs thence with Memminger Street N. 18 E. 10 feet to stake; thence S. 76 E. 209 feet to a stake; thence S. 18 W. 10 feet to a stake at the northeast corner of Lot No. 6; thence along the line of No. 6 N. 76 W. 209 feet to the beginning corner and being the same strip conveyed to Annie A.
