(hereinsfier referred to as Mortgagos) as evidenced by the Mortgagor's promissory note of even data hereinth, the terms of which are incorporated herein by reference in the sum of Twenty-Three Hundred and No/100
DOLLARS (\$ 2300.00) with interest thereon from date at the rate of Six (6%)--per centum per annum, said principal and interest to be small as therein stated, and

WHEREAS, the Mortgagor may hereafter become injected to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has grapted, bargained, sold and released, and by these presents does grant, bargain, sell and release nato the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Buncombe Road, near the corporate limits of the City of Greenville, and having the following metes and bounds, to-wit:

"BEGINNING at a stake on Buncombe Street, corner of lot No. 3, and running thence S. 78 W. 203 feet to a stake; thence S. 132 K. 66 feet to a stake, corner of lot No. 5; thence N. 78 E. 203 feet to a stake on Buncombe Street; thence N. 132 W. 66 feet along Buncombe Street to the beginning corner, known as let No. 4 in survey of Verner lands, made by W. A. Hudson, November 28, 1904, and being the same premises conveyed to the mortgagor by deed recorded in Volume 107 at Page 400."
