"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, being known and designated as Lot No. 9 and a small portion of Lot No. 8, according to plat of property of G. B. Lee, recorded in Plat Book K, page 43, and being more particularly described by survey and plat of R. E. Dalton dated July 10, 1944, as follows:

"BEGINNING at an iron pin at the southern corner of Eastlan Drive, (Formerly Buena Vista Avenue and Wickliffe Street) thence with said drive or Wickliffe Street, S. 54-55 E. 175 feet to iron pin; thence S. 53-10 W. 52.75 feet to iron pin; thence N. 55-0 W. 177.8 feet to a stake on the southeast side of said Drive or Buena Vista Avenue; thence N. 36-13 E. 53 feet to the beginning corner. Being the same lot of land conveyed to us by Harold K. Stilwell by deed dated April 17, 1946 and recorded in the R. M. C. office for Greenville County in Deed Vol. 293, page 265."
