WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as lot # 12 as shown on plat of American Bank and Trust Company property prepared by R. E. Dalton, February 1922, recorded in Plat Book "F", at Page 44, and being more particularly described, according to said plat as follows:

"BEGINNING at an iron pin on the Western side of Anderson Road, joint corner of lots # 11 and 12, and running thence N. 53-40 W. 137.9 feet, more or less, to iron pin in line of lot # 15; thence with line of said lot, S. 42-43 W. 49.8 feet to an iron pin in corner of lot # 13; thence with line of said lot # 13, S. 53-40 E. 136.5 feet, more or less, to an iron pin on Anderson Road; thence with the Western side of Anderson Road, N. 44-15 E. 50 feet to the beginning corner. Being the same premises conveyed to the mortgagor by Cherry Investment Company by deed dated March 4, 1943, recorded in Book of Deeds 251 at Page 332."
