All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the West side of Wait Street near the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lot 16 of Block B, on plat of East Highlands Estates, made by Dalton & Neves, Engineers, April 1940, recorded in the R. M. C. Office for Greenville County in Plat Book K, at pages 35 and 36, and having according to said plat and a recent survey made by R. W. Dalton, Surveyor, August 5, 1948, the following metes and bounds, to-wit:
