WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Five Hundred and No/100- - - - - - - - - - - DOLLARS (\$2500.00), with interest thereon from date at the rate of Six (6%)- - - per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, about 3½ miles North of Greenville, and being shown and designated as lot # 15 as shown on a plat of the subdivision of Buncombe Park, prepared by W. J. Riddle, Surveyor, May 1944, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin on the North side of Buncombe Park, joint front corner of lots # 14 and 15, which point is 860 feet in an Easterly direction from the intersection of South Haven Drive and Buncombe Road, and running thence with joint line of said lots, N. 3-20 W. 150 feet to an iron pin; thence N. 88 E. 80 feet to an iron pin, joint rear corner of lots # 15 and 16; thence with joint line of said lots, S. 3-20 E. 150 feet to iron pin in the North side of South Haven Drive; thence with said Drive, S. 88 W. 80 feet to the beginning corner. Being the same premises conveyed to the mortgagor by Floride M. Turner by deed dated 30th of April, 1948, recorded in Volume 345 at Page 29."

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
