All that piece, parcel or lot of land in Eates Township, Green-ville County, State of South Carolina, containing one acre, more or less being situate at the most westerly corner of my tract of land and also being situate on the north side of the Buncombe Road and on the east or southeast side of a County Road and being more particularly described as follows:
