"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the West side of Rocky Slope Road and just South of the Woodruff Road in Butler Township, being shown as Lots No. 7, 8, 10, 11 and 12, and part of Lot 9, on Plat of property of E. R. Haynie, made by P. B. Wilson, Jr., Surveyor, October 1945, which plat is recorded in Plat Book "S" at page 163, in the R. M. C. Office for Greenville County, S. C. and containing, according to said plat, an aggregate of 28.66 acres, and being described together as follows:
