Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina: All that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as lots Nos. 21,22 and 23, Block D, Stone Estates, as per plat thereof recorded in Plat Book G, at Page 292 in the R.M.C. Office for said County, and also, according to a recent survey thereof made by A. C. Crouch, Registered Engineer, dated November 13, 1948. Said lot having a frontage of 75 feet on Druid Street, a depth of 160 feet on the South, 160 feet on the North, 75 feet across the rear, and being located 75 feet in a Southerly direction from Reid Street.
