NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing one acre, more or less, situate on the Northwest side of a 19 foot road leading Northeast from a County Road which is sometimes referred to as Hillandale Road, near Hillandale Golf Course, in Paris Mountain Township, and having according to a plat made by Dalton & Neves, Engineers, August 1948, the following courses and distances, to-wit:

"BEGINNING at an iron pin on the Northwest side of said 19 foot road at corner of W. J. Norris, said pin being 210 feet in a northeasterly direction from the intersection of said 19 foot road and the Hillandale Road, and running thence along the Northwest side of said 19 foot road, N. 27-30 E. 210 feet to iron pin; thence N. 36-30 W. 210 feet to an iron pin in line of property of J. M. Black; thence with the line of Black property, S. 27-30 W. 210 feet to iron pin at rear corner of W. J. Norris lot; thence with line of said lot, S. 36-30 E. 210 feet to an iron pin in Northwest side of 19 foot road, the point of beginning. Being the same premises conveyed to the mortgagor by J. M. Black by deed recorded in Volume 358 at Page 31."

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
