All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the Southeast aide of Berkley Avenue, near the City of Greenville, in Greenville County, South Carolina, being shown as part of Lots 403 and 404 on plat of property of Colonia Company, made by Dalton & Neves, Engineers, February 1938, recorded in R. M. C. Office for Greenville County, S.C. in Plat Book "J", pages 4 and 5, and having according to said plat and a recent survey made by R. W. Dalton, Surveyor, March 2, 1949, the following metes and bounds, to-wit:
