NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, near the City of Greenville, on the North side of Aberdeen Avenue, being known and designated as lot No. 5 of the property of Parrish & Gower, nad having, according to a plat recorded in the R. M. C. Office for Greenville County in Plat Book "G" at Page 236, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Northern line of Aberdeen Avenue, and running thence N. 66-24 W. 171.8 feet, more or less, to an iron pin; thence N. 24-35 E. 64 feet to an iron pin; thence S. 66-24 E. 170.1 feet, more or less, to an iron pin in Northern line of Aberdeen Avenue; thence with the Northern line of Aberdeen Avenue, S. 22-54 W. 64 feet to the point of beginning."

Said premises being the same conveyed to the mortgagor by Robert A. Brown, Jr. by deed dated October 4, 1940, recorded in Volume 226 at Page 246.
