"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as Lot No. 17, Block C of the subdivision known as Kanatenah as shown on Plat of the same recorded in Plat Book F at Pages 131 and 132, and being more particularly described according to said Plat, as follows:

*BEGINNING at a point on the South side of Stewart Street, joint front corner of Lots Nos. 17 and 18, and running thence with the joint lines of said lots, S. 26-30 E. 165 feet to a point at the joint rear corner of Lots Nos. 8, 9, 17 and 18; thence with the joint rear line of Lots Nos. 8 and 17, S. 63-35 W. 60 feet to a point at the joint rear corner of Lots Nos. 7, 8, 16 and 17; thence with the joint lines of Lots Nos. 16 and 17, N. 26-30 W. 165 feet to a point on the South side of Stewart Street, joint front corner of Lots Nos. 16 and 17; thence with the South side of Stewart Street, N. 63-35 E. 60 feet to the beginning corner."
