MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Greenville Home Builders, Inc. (hereinafter referred to as Mortgagor) SEND(S) GREETING:

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Hundred Fifty and No/100

DOLLARS (\$ 750.00 ),

with interest thereon from ~~date~~ maturity at the rate of six per centum per annum, said principal and interest to be repaid: on or before one year after date, with interest thereon from maturity at the rate of Six (6%) per cent, per annum, to be computed and paid annually

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of Irene Circle, near the City of Greenville, being shown as lot No. 13 on Plat of Royal Heights, made by Dalton & Neves in April, 1949, recorded in Plat Book W at Page 25, and described as follows:

"BEGINNING at a stake on the Southern side of Irene Circle, 34.3 feet West from the right angle turn of Irene Circle at corner of lot No. 12, and running thence with the line of said lot, S. 30-17 W. 153 feet to a stake in line of lot No. 5; thence with the line of lots Nos. 5 and 4, N. 63-53 W. 60 feet to a stake at corner of lot No. 14; thence with the line of said lot, N. 30-17 E. 153 feet to a stake on Irene Circle; thence with the Southern side of said Circle S. 63-53 E. 60 feet to the beginning corner."
