"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as lot No. 11 as shown on a plat of the property of the Ethel Y. Perry Estate, prepared by W. J. Riddle in November 1947, recorded in Plat Book R, at Page 127, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin on the South side of Darlington Avenue, joint front corner of lots Nos. 11 and 12, which pin is 63.5 feet Northeast of the intersection of Darlington Avenue and Dykeson Avenue, and running thence S. 47-00 E. 141 feet to an iron pin in line of lot No. 2; thence with line of lot No. 2, N. 43-00 E. 60 feet to an iron pin in line of lot No. 10; thence with line of lot No. 10, N. 47-00 W. 141 feet to an iron pin on Darlington Avenue; thence with said Avenue, S. 43-00 W. 60 feet to the beginning corner."
