"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, situate at the Northwest corner of the intersection of the Old Rutherford Road, and Pine Avenue, and being more particularly described by metes and bounds, as follows:

"BEGINNING at an iron pin at the Northwest corner of the intersection of Old Rutherford Road and Pine Avenue, and running thence with the North side of Pine Avenue, N. 81-20 W. 145 feet to iron pin at corner of lot heretofore conveyed to Paul C. Dillard; thence with line of Dillard property, N. 8-40 E. 170 feet to iron pin; thence, N. 81-20 W. 90 feet to iron pin in line of property now or formerly owned by Henry Bryant; thence with line of said property, N. 8-40 E. 105 feet to iron pin; thence S. 81-20 E. 250 feet to iron pin on Rutherford Road; thence with the Rutherford Road, S. 11-30 W. 277 feet to the point of beginning."
