"All that certain pieces parcelsor lotsof land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, described as follows:

(1) On the western side of Casey Street, being shown as Lot B on Plat of property of J. W. Henderson, made by Pickell & Pickell on February 18, 1950, and described as follows:
