All that certain lot of land in Chick Springs Township, Greenville County, State of South Carolina, on the south side of Piney Mountain, fronting on a road leading from the new McGee Road up Piney Mountain to the old Cutimo house, adjoining lands of J. P. Griffin, the old Cutino lands and McGee lands, and having the following metes and bounds:

BEGINNING at an iron pin on line of old Cutino lot, thence S. 48 1/4 W. 2.25 chains to iron pin on line of McGee lands; thence S. 17 1/4 E. 3.94 chains to iron pin on southeast side of plantation road and on Griffin line; thence N. 34 E. .69 of a chain to the beginning corner, containing one-half of an acre, more or less.
