"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of Carey Street, farmerly East Croft Street, in the City of Greenville, being known and designated as Lot No. 3 on the Plat of D. R. Cain, Trustee, recorded in Plat Book H at Page 135, and described as follows:
