Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville State of South Carolina: in the City of Greenville, in School District 7Hl, and being known and designated as lot No. 11 of Block I, of Section 5, of East Highland Estates as shown on plat recorded in Plat Book K, at Pages 79 and 80, and being more particularly described according to a recent survey by Piedmont Engineering Service March 16, 1950, as follows:

BEGINNING at an iron pin on the Western side of Carolina Avenue, joint front corner of lots Nos. 11 and 12, and running thence with Carolina Avenue, N. 26-30 W. 70 feet to an iron pin on the South side of a five foot alley; thence with said alley, S. 60-29 W. 175.6 feet to an iron pin in the East side of another five foot alley; thence with said alley, S. 21-13 E. 50 feet to an iron pin, joint rear corner of lots Nos. 11 and 12; thence with joint line of said lots, N. 67-02 E. 180.5 feet to the point of beginning.
