in and by... my... certain promissory note, in writing, of even date with these presents. am... well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of SIX THOUSAND, FIVE HUNDRED AND NO/100 - - - (\$.6,500.CQ.)

Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of SIXTY -FIVE AND NO/100 - - - (\$.65.00...)

Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and fore-close this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of ...Greenville, ...Greenville. Township, now within the corporate limits of the City of Greenville, being a portion of bots los. 32 and 33 of a subdivision known as hastover, according to a plat thereof prepared by R. E. Dalten, Engineer, July, 1920 and recorded in the R. M. C. office for Greenville County in Plat Book F, at page 42, and being known and designated as Lot A of the property of Massalena Bowen, according to a plat thereof prepared by Pichell and Pichell, angine rs, July 18, 1949, and having, according to said later plat, the following metes and bounds, to-wit:

"BEGINNING at an iron min at the Northwest corner of the intersection of Laco street with Ackley street, and running thence with the Northeast side of Maco street, N. 36-10 W. 100 feet to the corner of Lot o; thence along the line of said Lot B, N. 63-44 E. 145.2 feet to an iron nin on the line of Lot No. 34; thence along the line of that lot, S. 25-30 m. 100 feet to an iron pin on the Northwest side of Ackley street; thence with the Northwest side of Ackley street, S. 64-30 W. 127 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
