All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the South side of James Drive, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot 23, on Plat of Orderest Park, made by C. C. Jones, Engineer, July 1948, recorded in the R. M. C. Office for Green - ville County, S. C., in Plat Book "S", at page 109, said lot fronting 65 feet along the South side of James Drive, and running back to a depth of 160 feet on the East side, a depth of 160 feet on the West side, and being 65 feet across the rear.

ALSO, that one Kleer Kleen 72,000 BTU Oil Floor Furnace, one National 30 gallon electric water heater, one disappearing stairway, and overhead insulation in the dwelling on the above property which the mortgager herein acknowledges to be a part of the mortgaged property.
