of said note, and also in consideration of the further sum of Three Dollars tome, the said
in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, the following described property, to-wit:
"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon,
situate, lying and being in the State of South Carolina, County of .Greenville., and .in .Greenville Township, School District 7-ID, now within the corporate limits of the City of Greenville, on the Southwest side of Beechwood avenue, and being known and designated as a portion of Lots Nos. 76 and 78 of a subdivision known as Eastover, as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book F, at page 42, and having, according to a more recent survey made by W. D. Neves, Engr., the following metes and bounds, to-wit:
"BEGINNING at an iron pin on the Southwest side of Beechwood avenue at the corner of Lot No. 75, and running thence along the line of that lot, S. 64-30 W. 213.5 feet to an iron pin at the rear corner of Lot No. 77; thence along the rear line of Lot No. 77, N. 25-30 W. 30 feet to an iron pin at the rear corner of lot now or formerly owned by Benson; thence along the line of that lot, N. 46-00 E. 132.8 feet to an iron pin on the Southwest side of Beechwood avenue; thence along the line of Beechwood avenue, S. 71-55 E. 108.8 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are nereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to me by G. B. Lee by deed dated May 25, 1937 and recorded in the R. M. C. office for Greenville County in Vol. 198, page 146."
