*BEGINNING at an iron pin on the east side of the Buncombe Road, at the joint corner of Lots 1 and 2, which point is 100 feet northeast from the southern boundary of the original Love property, and running thence along the joint line of Lots 1 and 2, S. 75 E. 570 feet to an iron pin, joint rear corner of said Lots 1 and 2, on the west side of a branch; thence up said branch, in a northerly direction, 38 feet to an iron pin, joint rear corner of Lots 2 and 3; thence along the joint line of said lots 2 and 3, N. 69-10 W. 554 feet to an iron pin, joint corner of said Lots 2 and 3, on Buncombe Road; thence along the line of said Buncombe Road, S. 29-40 W. 100 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
