All that certain piece, parcel or lot of land, together with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in Greenville County, South Carolina, being on the south side of the Parkins Mill Road, known and designated as Lot #1, according to a plat of the property of John B. Scoggins, prepared by W. J. Riddle, Surveyor, August 1949, and having, according to said plat, the following metes and bounds, to-wit:
