Whereas, I the said Robert E. Smith

in and by my certain Note or obligation bearing even date herewith, stand indebted unto The Prudential Insurance Company of America

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the West side of Sevier Street in that area recently annexed to the City of Greenville, in County of Greenville, State of South Carolina, being shown as Lots 47 and 100 on Plat of Park Hill, made by Dalton & Neves, Engineers, May 1940, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "J", pages 208-209, said lots together having a frontage of 194.7 feet (chord measurement) along the West side of Sevier Street, running back to a depth of 176.5 feet on the North side, to a depth of 231.7 feet on the South side and being 154.6 feet across the rear.
