NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwestern side of U. S. Highway #25 (New Buncombe Road) near the City of Greenville being the Northwestern one-half of Lot 5 as shown on a plat of the property of Harriett H. Parker made by Dalton & Neves in November 1939 recorded in Plat Book "J" at pages 142 and 143 and described as follows:

BEGINNING at a stake on the Southwestern side of Buncombe Road at corner of Lot 4 and running thence with the line of said lot S. 26-15 W. 642.4 feet to a stake on a 40 foot street; thence with the Northeastern side of said street S. 38-51 E. 75.12 feet to a stake; thence N. 26-15 E. 642.6 feet to a stake on Buncombe Road; thence with the Southwestern side of said road N. 39-03 W. 75.12 feet to the beginning corner; and being the same property conveyed to J. R. Ellis by E. C. Ellis by deed dated September 17, 1941, recorded in Book 237, page 374.
