Township, and being known and designated as Lot No. 12, of Block E, in a subdivision known as "Kanatenah", as shown on revised plat thereof recorded in the R. M. C. office for Greenville County in Plat Book F, at page 131, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southeast side of Cureton Street at the joint corner of Lots Nos. 11 and 12, of Block E, which point is 181.5 feet east from the southeast corner of the intersection of a 40-foot unnamed street with Cureton Street, and running thence along the joint line of Lots Nos. 11 and 12, of Block E; S. 26-30 E. 134.8 feet to an iron pin at the joint corner of said lots; thence N. 63-35 E. 60 feet to an iron pin at the joint rear corner of Lots Nos. 12 and 13; thence along the joint line of said lots, N. 26-30 W. 142.4 feet to the joint corner of said lots on Cureton Street; thence along the line of Cureton Street, S. 56-21 W. 60.5 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
