"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of . Greenwille, and in Greenville Township, on the north side of the old Spartanburg Road, about 12 miles from the Greenville County Court House, containing approximately 1 acre, and having, according to a plat thereof made by R. E. Dalton, Engr., in November, 1922, the following metes and bounds, to-wit:
