

with interest until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

C., its Successors and Assigns forever all that piece, parcel or tract of land in Grove Township, County of Greenville, State of South Carolina, on the northwest side of the Moonville Road, containing 14 acres, more or less, and having the following metes and bounds according to a survey made by W. J. Riddle, September, 1947:

BEGINNING at the center of the intersection of the Grove Road and the Moonville Road and running thence N. 23-35 E. 102 feet to a pin; thence N. 41-45 W. 1435 feet to a pin; thence S. 63-45 W. 314 feet to a pin; thence S. 34 E. 98 feet to a pin; thence 8. 69-30 E: 93 feet to a pin; thence S. 22-40 E. 1302 feet to a point in the center of the Moonville Road; thence along the center of said road N. 62-20 E. 561.2 feet to the beginning corner. Said property being the same that was conveyed to the mortgagor herein by L. L. Baty, by deed dated May 19, 1950, and being of record in the R.M.C.
