And the said most pages (s) agree(s) to insure and keep insured the houses and buildings on said lot in a sum not less than Thirty-five Hundred & no/100 - - (\$3,500.00) - - Dollars in a company or companies satisfactory to the mortgages(s) from loss or damage by fire, with extended coverage endorsement thereon, and assign and deliver the policies of insurance to the said mortgages(s) and that in the event the mortgager(s) shall at any time fail to do so, then the mortgages(s) may cause the same to be insured and reimburse itself for the premium, with interest, under this mortgage; or the mortgages(s) at its election may on such failure declare the debt due and institute foreclosure proceedings.
