All that lot of land situate on the Northwest side of Crestline Road, near the City of Greenville, in Faris Mountain Township, Greenville County, State of South Carolina, shown as Lot 13 and the Western onenalf of Lot 14, of Block "A", on plat of Hillandale Heights made by T. M. Welborn, Surveyor, October 7, 1950, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "Y", at page 61, and having according to said plat, the following metes and bounds, to-wit:
