C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Hundred and No/100- - - - -

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the South side of East McBee Avenue, being shown as lot 5, Block 7, Page 63, of the City Block Book, and being more particularly described by metes and bounds, as follows:

"BEGINNING at a pin on the South side of East McBee Avenue, corner of lot now or formerly owned by Caroline Carter, and running thence with the line of the Carter lot, S. 20 W. 78 feet to line of lot now or formerly owned by A. B. Steele; thence with the line of the Steele lot, S. 70½ E. 35 feet to pin at corner of lot formerly owned by L. M. McBee, and Henry Briggs; thence with line of the Briggs lot, No. 20-70 E. 78 feet to pin on McBee Avenue; thence with the South side of East McBee Avenue, N. 70½ W. 35 feet to the point of beginning."
