**MORTGAGE**

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Southeastern side of Bradley Boulevard, being known and designated as Lot No. 62 as shown on Plat of University Park, recorded in Plat Book S at Page 127, and described as follows:

"BEGINNING at an iron pin 71 feet from the intersection of Bradley Boulevard and Stephens Lane, at the joint front corner of Lots Nos. 61 and 62, and running thence with the joint line of said lots, S. 37-34 E. 175 feet to an iron pin on the Northwest side of a 20-foot alley; thence with said alley, N. 56-22 E. 71 feet to an iron pin, joint rear corner of Lots Nos. 62 and 63; thence with the joint line of said lots, N. 37-34 W. 175 feet to an iron pin on the Southeastern side of Bradley Boulevard; thence with said Bradley Boulevard, S. 56-22 W. 71 feet to the point of beginning."
