And I do hereby agree to insure the house and buildings on said lot in a sum not less than Seven Thousand and No/100 - - - - - - - - (\$7000.00) Dollars fire insurance and not less than Seven Thousand and No/100 - - - - - - - (\$7000.00) Dollars extended coverage insurance, in a company or companies acceptable to the mortgagee, and to keep same insured from loss or damage by fire or windstorm, and do hereby assign said policy or policies of insurance to the said mortgagee, its successors and assigns; and in the event I should at any time fail to insure said premises, or pay the premiums thereon, then the said mortgagee, its successors and assigns, may cause the buildings to be insured in $\frac{my}{m}$ name, and reimburse itself for the premiums and expense of such insurance under this mortgage, with interest.
