ALSO: "All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, on the northeast side of Highway No. 253 from Travelers Rest to Greenville, being a part of the land known as the land conveyed to Roy C. Campbell from Jennie Burns by deed recorded in the R.M.C. office for Greenville County in Deed Book 144, at page 200, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin in said highway, corner of the above described property, and running thence N. 41 E. 730.5 feet along the line of said property and to other property now or formerly belonging to Ray E. McAlister to a point in Pole Branch, iron pin; thence in a southwesterly direction along the center of Pole Branch 648.12 feet to a point in said highway; thence along said highway, N. 66-15 W. 247 feet to the point of beginning, bounded by other lands of the mortgagor on the northwest, Styles on the southeast, said highway on the southwest, being triangular in shape and containing 2.32 acres, more or less; being the same conveyed to me by Joe C. TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the Premises before mentioned unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, its successors and assigns forever.

And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular the said Premises unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, its successors and assigns, from and against me and my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming or to claim the same or any part thereof.

And it is hereby agreed that the mortgagor shall insure his life in the amount of \$\_\_\_\_\_\_\_\_, and assign said policy to the mortgagee, its successors or assigns, and does hereby expressly authorize the mortgagee to advance premiums upon said policy or policies annually and to add such premiums advanced to the balance due on this mortgage, and the mortgagor agrees to repay said premiums in twelve equal monthly instalments in addition to the monthly payments herein above set out with interest at the same rate as provided in this mortgage.

And I do hereby agree to insure the house and buildings on said lot in a sum not less than Forty-Eight Hundred and No/100 - - - - - - - (\$ 4800.00 ) Dollars fire insurance and not less than Forty-Eight Hundred and No/100 - - - - - - - (\$4800.00 ) Dollars extended coverage insurance, in a company or companies acceptable to the mortgagee, and to keep same insured from loss or damage by fire or windstorm, and do hereby assign said policy or policies of insurance to the said mortgagee, its successors and assigns; and in the event I should at any time fail to insure said premises, or pay the premiums thereon, then the said mortgagee, its successors and assigns, may cause the buildings to be insured in my name, and reimburse itself for the premiums and expense of such insurance under this mortgage, with interest.

And I do hereby agree to pay all taxes and other public assessments against this property on or before the first day of January of each calendar year, and to exhibit the tax receipts at the offices of the FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, immediately upon payment, until all amounts due under this mortgage, have been paid in full, and should I fail to pay said taxes and other governmental assessments, the mortgagee may, at its option, pay same and charge the amounts so paid to the mortgage debt, and collect same under this mortgage, with interest, in twelve equal monthly instalments in addition to regular monthly payments.

And it is hereby agreed as a part of the consideration for the loan herein secured, that the mortgagor—shall keep the premises herein described in good repair, and should—I—fail to do so, the mortgage, its successors or assigns, may enter upon said premises, make whatever repairs are necessary, and charge the expenses for such repairs to the mortgage debt and collect same under this mortgage, with interest, in twelve equal monthly instalments in addition to regular monthly payments.
