All of those parcels or lots of land in the City of Greer, in Chick Springs Township of Greenville County, South Carolina, lying on the North side of Fairview Avenue, known and designated as lots Nos. 2 and 3 on a plat of property made for the Mrs. Hattie Payne Estate by H.S. Brockman, Surveyor, dated October 16, 1946, and having the following courses and distances:
