"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, in Chick

Springs Township, about two miles southwest of Greer, lying on the East side of the Buncombe Road and on the northern side of a road that connects the Buncombe Road with the Old Pelham Road, bounded on the North by lands of W.L. Henderson, on the East by lands formerly owned by J.H. James, on the South by second mentioned road and lands of I.M. Wood Estate, and on the West by the Buncombe Road and lands of W.L. Henderson, and having the following courses and distances:
