in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, according to the terms of said note, and also in consideration of the further sum of Three Dollars in the

the said G. D. Coagins, in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents the receipt whereof is best by acknowledged, have granted, bargained, sold and received and by these presents do hereby grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, on the west side of Pine Street, being known and designated as Lot No. 1 of a subdivision known as Woodlawn Heights, a plan or plat thereof recorded in the R. M. C. Office for Greenville County, in Plat Book L, at pages 14 and 15, and being more particularly described as follows:

"BEGINNING at an iron pin on the west side of Pine Street, at a point approximate-
ly 224.5 feet south of the intersection of Pine Street, at the corner of Lot No. 5, and
running thence along the line of Lot No. 5, N. 5° 15' W., 14 feet to an iron pin in a
branch at the rear corner of Lot No. 5, thence along the branch in a southeasterly
direction 109 feet, more or less, to an iron pin at the rear corner of Lot No. 5,
thence along the line of Lot No. 5, S. 82° 15' E., 14 feet to an iron pin at the corner of
said lot on the west side of Pine Street, thence along the line of said Pine Street,
N. 16° 20' E., 143 feet to the beginning corner including the plumbing, electrical and
heating fixtures now located on said premises, or to be installed thereon, which are
hereby expressly agreed to be a part of the property. Being a portion of the property
conveyed to me by H. H. Willis by his deed dated April 11, 1913 and recorded in the
R. M. office for Greenville County on Nov. 25, 1913, page 261.
