Dollars (\$11,000.00), with interest from date at the rate of

Four ~~per centum~~ per centum (4%) per annum until paid, said principal and interest being payable at the office of Fidelity Federal Savings & Loan Association

in Greenville, S. C., or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of ~~\$100.00~~ Dollars (\$100.00)

on October ~~15~~, 1951, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of September, 1971.

Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents; the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagor, its successors and assigns, the following-described property situated in the county of Greenville, State of South Carolina; on the east side of Carolina Avenue, near the City of Greenville, known as lot 8, Block J, section 5, of lot 8 of West Highlands Addition, Greenville, South Carolina; February, 1941, recorded in the R.M.C. Office in Plat Book at page 76, 77, 78, and 80, and described as follows:

BUILDING at an iron pin on the east side of Carolina Avenue, on the north corner of lots 7 and 8 of Block J, and running thence with the line of lot 7, 176.4 feet to an iron pin on the west side of a 5-foot strip of land reserved for utilities; thence with the west side of the aforesaid strip running southwesterly, 3.00-24 E. 70 feet to an iron pin coincident with the line of lot 8, S. 00-36 E. 176.4 feet to an iron pin on the east side of Carolina Avenue; thence with the line of Carolina Avenue, N. 00-56 E. 61 feet to the southern corner of the aforesaid building; the said conveyed to the Mortgagor by deed signed and recorded in Volume 312 at page 214, the other recorded in Volume 312 at page 116.

LAND, lot 8, Block J, section 5, as described above, bounded to the east and south as follows:

From point #3 at an iron pin on the east side of Carolina Avenue, running northwesterly, 176.4 feet to another iron pin on the eastern side of a 5-foot strip reserved for utilities, coincident with the strip, S. 00-24 E. 177 feet to an iron pin, and running easterly 16' 8" south of the aforesaid iron pin, thence with the point line easterly, 16' 8" to the point of beginning. Being the aforesaid conveyance given to the Mortgagor by Julia Mae Macs by deed to be recorded hereinafter.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); and fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are and shall be deemed to be fixtures and a part of the realty, and are a portion of the security for the indebtedness herein mentioned;
