with interest from date at the rate of four (4%) per centum per annum until paid; interest to be computed and paid semi-annually and if unpaid when due to bear interest at same rate as principal until paid, and we have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereto had will more fully appear.

NOW, KNOW ALL MEN, That we, the said W. B. Mix and Gertrude F. Mix

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to us, in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said South Carolina National Bank, trustee for the employees retirement plan of Union Bleachery,

All that certain piece, parcel or tract of land situate, lying and being in the Paris Mountain Township, about four miles north of the Greenville County Court House, on the northwest side of a road leading from the New Buhcombe Road through the Hillendale Golf Course (sometimes referred to as Thompson Road), in Greenville County, South Carolina, containing twenty (20) acres, more or less, acceding to a plan made by Madison H. Woodward, Surveyor, dated March 9, 1946, and having according to said plan the following particular bounds, to-wit:

Beginning at an iron pin on the northwest side of the road leading from the New Buhcombe Road through the Hillendale Golf Course at corner of said golf course property and running thence with said line N. 79-10 W. 1112.2 feet to a stone; thence N. 79-10 W. 554 feet to an iron pin; thence N. 4-21 E. 167 feet to an iron pin; thence N. 60-49 E. 483 feet to an iron pin; thence E. 33-10 E. 167 feet to an iron pin; the corner of property now or formerly of L. A. Wesley; thence with line of property now or formerly of L. A. Wesley S. 40-08 E. 780 feet to an iron pin; thence continuing with property now or formerly of L. A. Wesley S. 60-12 E. 509.1 feet to an iron pin on the road above mentioned; thence with said road S. 14-36 W. 200 feet to an iron pin; thence continuing with said road S. 20-11 W. 136.4 feet to an iron pin; thence still with said road S. 37-06 W. 144 feet to the beginning corner.
