NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for this account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, on the northern side of Cureton Street; near the city of Greenville, being known as lot No. 1 on plat of the estate of J. A. Davenport, made by R. E.Dalton, Engineer, December 192h, and having, according to survey made by Dalton & Neves, July 1926, the following metes and bounds:

BEGINNING at an iron pin on the North side of Cureton Street, said pin being 572 feet from the northeast corner of the intersection of Cureton Street and Augusta Road, and running thence with the line of Lot No. 2, N 31-hl W. 173.8 feet to an iron pin; thence N. 63-h2 E. 77/1 feet to an iron pin; thence S 25-51 E. 167 feet to an iron pin, on the north side of Cureton Street; thence with the north side of Cureton Street, S 58-19 W. 60 feet to the beginning corner; being the same property conveyed to the mortgagor herein by J.
