"BEGINNING at an iron bin on the west side of Dargan Avenue at the joint front corner of Lots Nos. 2 and 3, which point is 180 fee; south of the intersection of Florida Avenue Extension, and running thence along the joint line of said lots, S. 75+ 47 W. 175 feet to an iron pin at the joint rear corner of said lots in the line of the Welcome School property; thence along the line of that property, S. 14-13 E. 85 feet to an iron pin at the joint rear corner of Lots Nos. 3 and 4; thence along the line of said lots, N. 75-47 E. 175 feet to an iron pin on the west side of Dargan Avenue; thence along the west side of Dargan Avenue, N. 14-13 W. 85 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
