NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, at Paris, known as lot 13, Block B, on plat of lands of Realty Corporation, recorded in Plat Book F at Page 211, and more particularly described as follows:

"BEGINNING at an iron pipe on Cuttino Road, 98 feet from Northeast corner of said road and National Highway, and running thence with Cuttino Road, N. 70 W. 100 feet to iron pipe, corner of lot 14; thence with line of lot 14, N. 21 E. 159.8 feet to iron pipe in line of lot 17; thence with line of lot 17, S. 65-15 E. 77.5 feet to iron pipe; thence S. 12-33 W. 154.4 feet to the beginning corner."
