in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE. at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the East side of Vanderbilt Circle, being known and designated as Lot No. 86 of White Oak Subdivision of Northside Development Company, and being more particularly described according to a plat prepared by J. D. Pellett, Jr. in August, 1946, and recorded in the R. M. C. office for Greenville County in Plat Book P at page 121, as having the following courses and distances, to-wit:

"BEGINNING at an iron pin on Vanderbilt Circle, joint corner of Lots 86 and 87 and thence running along the joint line of said lots, S. 54-14 E. 208.2 feet to a stake at common rear corners of Lots Nos. 86, 87, 92 and 93; thence along the rear line of Lot No. 93, S. 4-56 E. 55 feet to a stake at the joint rear corners of Lots Nos. 85 and 86; thence along the joint line of said lots, N. 66-56 W. 238.5 feet to an iron pin on Vanderbilt Circle; thence along the line of Vanderbilt Circle, N. 29-02 E. 95 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to me by Northside Development Company by its deed dated October 23rd, 1951, not yet recorded."
