NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Saluda Township, having the following metes and bounds, to-wit:

"BEGINNING on a stake in the branch near a large poplar and running thence S. 63-30 W. 8.22 chains to a stake; thence S. 45 W. 7.94 chains to a stake in the road; thence with road, N. 74 W. 2.72 chains to a point in the road; thence N. 67 W. 3.86 chains to a point in road; thence N. 51-30 W. 3.62 chains to a point in road; thence N. 44 W. 2.90 chains to point of intersection in road; thence N. 44 E. 7.43 chains to stone; thence S. 82 E. 19.30 chains to stake in branch, the beginning corner, containing 15 acres, more or less, joined by lands of S. B. Cox and others and being a part of same land conveyed to S. B. Cox. Being the same property conveyed to the mortgagor by deed recorded in Volume 365 at Page 31."
