"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, and being known and designated as the Southeast corner of Tract No. 3. of the 9. L. Jones Estate as shown on plat thereof prepared by W. A. Hester, Surveyor, January 24, 1929, recorded in Plat Book G at Page 233, and described as follows:
