WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of Valley View Lane, near the City of Greenville, being shown as Lot No. 52 on Plat of Sylvan Hills, made by Piedmont Engineering Service in June 1948, recorded in Plat Book S at Page 103, and described as follows:

"BEGINNING at a stake on the Northern side of Valley View Lane 56 feet East from Morningside Drive, at corner of Lot No. 51, and running thence with the northern side of Valley View Lane, N. 84-24 E. 70 feet to a stake at corner of Lot No. 53; thence with the line of said lot, N. 5-36 W. 150 feet to stake at corner of Lot No. 65; thence with the line of said lot, S. 84-24 W. 70 feet to a stake at corner of Lot No. 51; thence with the line of said lot, S. 5-36 E. 150 feet to the beginning corner."
