WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Seven Thousand and no/100 DOLLARS (\$ 7,000.00), with interest thereon from date at the rate of six (6%)

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot #21, Section G, on a plat entitled "A R vision of a Portion of Croftstone Acres in and near Greenville, S. C.", made by Piedmont Engineering Service, Greenville, S. C., August 8, 1950, and recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "Y", page 91, and having according to said plat the following courses and distances:

BEGINNING at a point on the Northeast side of Mitchell Avenue, joint corner of Lots #20 and 21 of Section G, and running thence along the line of Lot #20 N. 40-10 E. 130 to a point; thence along Lot #22 S. 40-30-E. 149 feet to a point on a circle extension of M. tchell Avenue; thence along Mitchell Avenue S. 48-35 W. 100 feet to a point; thence along Mitchell Avenue N. 44-12 W. 110 feet to point of beginning.
